BACKGROUND:

This workshop is organised jointly by the University Paris-Dauphine (CGEMP/LEDa), the Grantham Research Institute on Climate Change and the Environment at the London School of Economics, and the Grantham Institute for Climate Change at Imperial College London. It builds on the experience of similar workshops hosted by the Oxford University Centre for the Environment in May 2008, and the LSE in May 2009.

The morning sessions seek to provide invited attendants - namely researchers and doctoral students in climate change economics - the opportunity to discuss their latest research results on (i) adaptation/mitigation issues and (ii) electricity/CO₂ markets in parallel sessions. Research papers' presentations are then discussed with the attendants. The discussions are widened in the afternoon to all stakeholders involved in climate change policies, including the business sector, policy makers and NGOs. After a brief summary of the morning sessions by their respective chairs, a round-table is organized to compare the British and the French latest climate policies developments.
